
The legal voters of the Town of South Hero are hereby warned to meet at the South Hero Town Office on Tuesday March 4, 2025, between 7 am and 7 pm to vote by Australian ballot to vote on the following articles:

- Article 1. To Elect Town Officers as required by law.
- Article 2. Shall the voters authorize General Fund expenditures for operating expenses of \$1,774,121 of which \$ 1,622,194 shall be raised by taxes and \$151,927 by non-tax revenues?
- Article 3. Shall the voters authorize Highway Fund expenditures for operating expenses of \$866,328 of which \$791,828 shall be raised by taxes and \$74,500 by non-tax revenue?
- Article 4. Shall the voters authorize town Library fund expenditures for operating expenses of \$165,960 of which \$125,960 shall be raised by taxes?
- Article 5. Shall the voters authorize a sum of \$10,000 to be raised by taxes for Cemetery expenditures?
- Article 6. Shall the voters authorize a sum of \$30,000 to be raised by taxes for Reappraisal expenditures?
- Article 7. Shall the Town of South Hero vote to pay its real estate taxes to the Town Treasurer in three installments with due dates being September 30th 2025, January 30, 2026 and April 30th, 2026. All installments are subject to late fees of 1% per month. Any unpaid balance after April 30th is subject to an additional 8% delinquent penalty fee
- Article 8. Shall the Town of South Hero set a rate of discount of 3% and a date of discount of September 30, 2025?
- Article 9. Shall the voters authorize the Selectboard to appoint a Town Treasurer as provided in 17 V.S.A. § 2651(f)?
- Article 10. Shall general obligation bonds or notes in an amount not to exceed Two Million Eight Hundred and Seventy-Five Thousand Dollars (\$2,875,000), subject to reduction by the application of federal and state grants-in-aid and reserve funds, be issued for the purpose of constructing a new town hall, the estimated cost of such improvements being Two Million Eight Hundred Seventy-Five Thousand Dollars (\$2,875,000)?
- Article 11. Shall the voters authorize the Select Board to apply any surplus from the current fiscal year to reduce taxes in the next fiscal year?

The legal voters of the Town of South Hero are further notified that voter qualifications, registration and absentee voting shall be as provided in chapter 43 & 51 of Title 17 V.S.A Statutes Annotated.





ARTICLE

Shall general obligation bonds or notes in an amount not to exceed Two Million Eight hundred and seventy-five thousand (\$2,875,000.), subject to reduction by the application of federal and state grants-in-aid and reserve funds, be issued for the purpose of constructing a new town hall, the estimated cost of such improvements being Two Million Eight hundred and Seventy-Five Dollars (\$2,875,000.)?

The legal voters of the Town of South Hero are further notified that voter qualification, registration and absentee voting relative to said annual meeting shall be as provided in Chapters 43, 51 and 55 of Title 17, Vermont Statutes Annotated.

The legal voters of the Town of South Hero are further notified that an informational meeting will be held on Saturday, March 1, 2025 am 9:00 AM o'clock in the morning, at the Folsom School a 75 South Street in South Hero for the purpose of discussing the proposition.




**SOUTH HERO TOWN SCHOOL DISTRICT

The legal voters of the South Hero Town School District are hereby notified and warned to meet at the South Hero Town Office, on Tuesday, March 4, 2025. Polls open between the hours of 7:00 A.M and 7:00 P.M. to vote by Australian ballot of the following articles:


- ARTICLE 1. Shall the voters of the school district approve the school board to expend \$5,491,980 which is the amount the school board has determined to be necessary for the ensuing fiscal year? The South Hero School District estimates that this proposed budget, if approved, will result in per pupil education spending of \$15,920 which is 3% higher than per pupil education spending for the current year
- ARTICLE 2. To Elect all School Officers as required by Law.
- ARTICLE 3. Shall the voters authorize the School Directors to use unencumbered funds from FY25 to first reduce any prior year school district deficit and then place any remaining unencumbered funds in a Reserve Fund for the purpose of capital improvements to the school facilities under the control and direction of the School Directors of the South Hero School District?
- ARTICLE 4. Shall the voters of the South Hero School District authorize the Board of School Directors to allocate any surplus funds from FY24 to cover part or all of an FY23 deficit?
- ARTICLE 5. Will the Town School District authorize the School Board to borrow in anticipation of taxes?
- ARTICLE 6. Shall the voters of the South Hero School District authorize the Board of School Directors to accept and expend such grant monies as may from time to time become available to the school district?




